Wednesday, June 24th, Governor Whitmer signed Executive Order (EO) 2020-131 into effect. This EO encourages the use of electronic signatures and remote notarization, witnessing, and visitation during the COVID-19 pandemic. Any electronic signature is now deemed enforceable and satisfies the law. For both Public and Private affairs any documents requiring a physical signature or notary may now be done remotely. The CDC has updated their recommendations for Pet Stores, Pet Distributors, and Pet Breeding Facilities. New findings show that there is no evidence animals play a significant role in spreading COVID-19 to people. However, there are a small number of animals that have been infected due to being in proximity of people with COVID-19. As of right now pets that are mammals can become infected while non-mammals such as birds, reptiles, fish, and insects do not appear to be susceptible to COVID-19.

U.S. Small Business Administration

On June 15th the Small Business Administration (SBA) began accepting new applications for Economic Injury Disaster Loans (EIDL) and Advances. These advances can be up to \$10,000 and do not have to be repaid. Any applications made before April 15th will be processed first and any new applications will be processed on a first come first serve basis.

The Michigan Economic Development Corporation (MEDC) partnered with Michigan Women Forwards in announcing the creation of a 1.5 million Michigan Entrepreneur Resilience Fund. The fund is meant to help entrepreneurs and small businesses impacted by COVID-19 recover. This fund offers \$1,000-\$5,000 grants and microloans of \$5,000-\$10,000 to small businesses.
