IRS Announcement

The IRS has recently announced additional guidance for Coronavirus-Related Distributions and Loans (CARES Act) with notice 2020-50. Lindabury, an MCAA legal partner, has covered this release and summed up the changes with this further guidance. If you have or might be considering taking a distribution from an eligible retirement plan this clarifies who would be classified as a "qualified individual" and reporting necessary for this type of loan.

Yesterday, June 29th, Governor Whitmer signed Executive Order (EO) 2020-138 into effect. This EO Encourages the all medical professionals to use telehealth services whenever possible. However, no other regulations that would be adhered to during a medical visit have changed. This order replaces and rescinds EO 2020-86. You can read both orders below:

U.S. Small Business Administration

On June 15th the Small Business Administration (SBA) began accepting new applications for Economic Injury Disaster Loans (EIDL) and Advances. These advances can be up to \$10,000 and do not have to be repaid. Any applications made before April 15th will be processed first and any new applications will be processed on a first come first serve basis.

The Michigan Economic Development Corporation (MEDC) partnered with Michigan Women Forwards in announcing the creation of a **1.5 million** Michigan Entrepreneur Resilience Fund. The fund is meant to help entrepreneurs and small businesses impacted by COVID-19 recover. This fund offers \$1,000-\$5,000 grants and microloans of \$5,000-\$10,000 to small businesses.
