Yesterday, June 30th, Governor Whitmer signed Executive Order (EO) 2020-140 into effect. This EO suspends the requirement for an in-person application of a work permit. Applications may now be made via mail, e-mail, fax, or a web based form. This Order is set to expire July 31, 2020 at 11:59 P.M.

Governor Whitmer has outlined provisions preK-12 schools will be required to operate under with Executive Order (EO) 2020-142. This Order requires every school district and nonpublic school to develop a COVID-19 preparedness plan and deadlines on submission of their plans to educational authorities by Mid-August. U.S. Small Business Administration

On June 15th the Small Business Administration (SBA) began accepting new applications for Economic Injury Disaster Loans (EIDL) and Advances. These advances can be up to \$10,000 and do not have to be repaid. Any applications made before April 15th will be processed first and any new applications will be processed on a first come first serve basis.
